



Limited Warranty for OverDrive™ AGM 31

Trojan Battery Company warrants only to the **original purchaser** that any OverDrive™ AGM 31 battery used in commercial truck auxiliary power unit applications which becomes unserviceable (not merely discharged) due to defect in material and/or workmanship within the free replacement period stated below (the “Warranty Period”) will be replaced without charge. This warranty is non-transferable.

WARRANTY EXCLUSIONS

Trojan Battery Company will not be responsible for any expenses for transportation, installation, recharging, electrical system tests, loss of time, loss of use of equipment, or other expenses which would be considered as incidental or consequential damages.

THE PROVISIONS OF THIS LIMITED WARRANTY SHALL NOT APPLY TO FAILURE DUE TO:

Abuse or neglect such as damage from shipping, loose wiring, rusted or corroded hardware, improper maintenance, improper installation, neglect, breakage, cracked covers and cases, bulged cases from heat, freezing, fire, explosion, wreckage, exposure to excessive heat or cold temperatures, the addition of any chemical or solution, insufficient charging (undercharging or overcharging), use of the battery in an uncharged condition, discharged batteries, improperly sized batteries or oversized battery sets, batteries damaged from electrical equipment or if the manufacturing codes have been destroyed or tampered with.

A battery will not be considered defective unless it fails to deliver 60% or less of its rated capacity (temperature corrected to 80°F) during the warranty period. The battery must be used in the application for which it was designed.

The battery owner will read warning labels on the battery and exercise due care in working on or around it. The battery is intended to be serviced by persons with training or experience with batteries.

HOW TO RECEIVE WARRANTY SERVICE:

To resolve problems covered by this warranty for commercial truck auxiliary power unit applications, contact the local distributor you purchased the batteries from to confirm the battery condition/defect. You will need to provide proof of purchase along with the date code for the batteries. The OverDrive™ AGM 31 Limited Warranty starts from the date sold and applies only to commercial truck auxiliary power unit applications. During the free replacement period, the battery will be repaired or replaced with an in kind replacement. Pro-ration is based on manufacturer’s suggested retail price at time of purchase using the formula below:

$$\frac{(\text{Manufacturer's Suggested Retail Price at time of purchase})}{\text{Warranty Period (in months)}} \times (\# \text{ of Months in Service}) = \text{Replacement Cost}$$

Trojan Battery Company makes no express warranties with respect to its batteries other than the limited warranties stated above.

Trojan Battery Company shall not have any liability for any incidental or consequential damages.

APPLICATION OF STATE LAW:

This warranty gives you specific legal rights, and you may also have other rights that vary from state to state.

OverDrive™ AGM 31 Warranty Examples

Scenario One:

Battery has been in use for 14 months and is delivering 40% of its rated capacity (temperature corrected to 80°F) and no abuse or neglect is detected. Customer purchased the battery at the manufacturer's suggested retail price (MSRP) of \$277.

Result:

Customer's battery will be repaired or replaced with an in kind replacement because it falls under the 18 month full replacement warranty period.

Scenario Two:

Battery is in use for 24 months and is delivering 40% of its rated capacity (temperature corrected to 80°F) and no abuse or neglect is detected. Customer purchased the battery at the manufacturer's suggested retail price (MSRP) of \$277.

Result:

Customer pays \$221.50 for a new battery because it falls past the 18 month full replacement warranty period and is pro-rata at the 24 months in use.

$$\$277 \text{ MSRP}/30 \text{ months} \times 24 \text{ months in use} = \$221.50$$

Scenario Three:

Battery is in use for 16 months and is delivering 40% of its rated capacity (temperature corrected to 80°F). There are signs of improper installation and maintenance. Customer purchased the battery at the manufacturer's suggested retail price (MSRP) of \$277.

Result:

Customer must purchase a new battery at full manufacturer's suggested retail price because battery is not covered in the OverDrive™ AGM 31 Limited Warranty due to abuse and/or neglect.
